COURSE DESCRIPTION

This one-day seminar will cover Special Inspection requirements for Post Installed Anchors installation. Installation of post-installed adhesive and mechanical anchors is required to have Special Inspection per International Building Code. The Washington Association of Building Officials (WABO) offers a Post Installed Anchors (PA) Special Inspection certification. This course and instructor offered by the NWCEL has been approved by WABO to meet this requirement. Students must pass the course exam to receive credit for this course.

Note: In the event a student fails a final exam, they will be required to retake the course to receive class credit. There are no exceptions for retakes of the final exam.

ABOUT THE INSTRUCTOR

Jerry Abson is a Structural Building inspector with the City of Seattle Department of Construction and Inspections. Mr. Abson began his career as a special inspector with Otto Rosenau in 1998, where he quickly became a senior special inspector with WABO certifications in reinforced concrete, PT concrete, shotcrete, structural masonry, structural steel and welding, spray applied fireproofing and lateral wood. He became a building inspector in 2005 and now monitors all concrete in Seattle as well as special inspection agencies and registered inspectors. Mr. Abson is also a voting member of WABO and is currently an instructor for Reinforced Concrete with ICC teaching in several states including New Jersey and California.
